<p>Putting Competition</p> <p>If there is no hole in one on the day, the closest to the pin on the par 3's (usually 4 pars 3's) can putt on the practise green from 20m. If they sink the putt, they can get R5 000. Included in above premiums. Important that the other players don't watch the others putt, or they will get a read of line and pace.</p>
